## Overview

### EOL13609

Cisco announces the end-of-sale and end-of-life dates for the Cisco Unified Border Element Version 12 Licenses. The last day to order the affected product(s) is January 31, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

Cisco Unified Border Element (CUBE) Version 12 offers are being withdrawn as they have been superseded. Newer license offers listed in Table 2, enable both version 12 and 14 CUBE systems and should be considered for all new purchases. This bulletin is not an End-of-Sale announcement for any aspect of the CUBE feature set for Cisco routers.

<b>End-of-Sale Date License</b>	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	January 31, 2021
<b>Last Ship Date License</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	January 31, 2021
<b>End of New Service Attachment Date License</b>	For equipment and software that is not covered by a service-and-support contract, this is the last date to order a new service-and-support contract or add the equipment and/or software to an existing service-and-support contract.	January 31, 2021
<b>End of Service Contract Renewal Date License</b>	The last date to extend or renew a service contract for the product.	January 31, 2021
